- Low sodium or no salt canned beans and vegetables
- Canned fruits packed in 100% juice or water
- No sugar added applesauce
- 100% Fruit juice
- Low sodium pasta sauce
- · Whole grain cereal and pasta
- Canned chicken or tuna in water
- Brown rice

In addition to healthier options in the food pantry, the Coalition also offers nutrition education opportunities as well as a hybrid client choice model, allowing recipients input on the food items they receive.
